# **DRAINS Feedback Survey Competition**

## **Terms and Conditions**

All information provided on how to enter the Competition and each prize (**Prize**) available to each winner (**Winner**) forms part of these Terms and Conditions. #### **COMPETITION PERIOD**

## WHO CAN ENTER THE COMPETITION
